- B. Health and Wellness Review and Canyon's Living Leader (7:05)
  - a. The district has several programs to keep employees healthy. Jeannie is responsible to attend meetings and bring back information from the district that promotes healthy living. Park Lane has received a \$300 stipend from the district to promote additional healthy activities for Park Lane staff. Some of the things she plans on doing are a healthy breakfast for the staff, snowshoeing meetups, yoga, and walking club.

- F. Teacher Cell Tower Grant Requests (7:50)

## G. SRSS-IE [New Screener Info] (8:00)

- a. Council discussed the new SRSS-IE introduced to the district this year. It is a behavior screening tool used in an effort to support students whom Tier 1 efforts may be insufficient. Teachers at the elementary use this screener three times a year in which they rate students in the following categories: 1. Steal, 2. Lie, cheat, sneak, 3. Behavior problem, 4. Peer rejection, 5. Low academic achievement, 6. Negative attitude, and 7. Aggressive behaviors.
  - i. Many concerns about this assessment were discussed including the validity, tracking students, and who has access to the information. Justin Jeffery is going to reach out to BJ Weller who is the Director of Responsive Services at the district to come and talk to the council at a future meeting. Parents who wish to opt their child out of this screening tool must come into the office at Park Lane.

## I. Other Concerns (8:45)

a. Safety: None at this time

- b. Operation Safe Passage Update from Chris Sharp
  - i. Operation Safe Passage is a program to protect children from being abducted while walking to and from school. It also enhances safe walking routes and reduces opportunities for bullies to intimidate other children. Volunteers receive an ID badge and then become part of a closed internet group where they receive information about any child abductions in the area, can report suspicious activity, and receive additional training. Essentially you serve as eves and ears for the community.
    - 1. You can become part of this program in 30 minutes, no appointment needed, by going into the Sandy City Police Department to complete a background check and then receive an ID badge.
- c. Student Dress Code Update: Council reviewed the district's changes to the student dress code. As a council we have no official feedback.
