# B. Operation Safe Passage Update

There are two levels of participation to volunteer—more information on the website. Basically just have your eyes open, but in some cases they can call people from the community to be called upon for help—must be background checked. Not likely to be called but possible—also if possible to occasionally walk the neighborhood ..will receive newsletter. Have 31 people in the Sandy area –would like more-including the principal so that they get the newsletter and emails. No one currently in Park Lane boundaries. A lot of parents are already walking here everyday, so they would just need to get the background check—for more eyes and ears. Law enforcement needs to know who they are using in event of a lost child—can't just send out everyone that wants to help. Alternative to the old "McGruff House" program. Training is easy—all online through a Google group. You also get a cool vest! The vest is so you visually stand out. Could be called for anything in Sandy City—a call doesn't mean you have to go. Background check takes about 20 minutes at the Sandy City Police Department. Takes about 3 minutes to fill out the online application. Training opportunity in May. It is volunteer-don't have to

commit to anything—you can be involved as much or as little as you want. Decision to put it in Justin's and the PTA's newsletter-email/Facebook Page. Trying to get bus drivers and crossing guards as well.

### C. SNAP Plan review

Discussed walking routes to Park Lane. There is no need for signs or a flashing school light because of the stop signs that are a certain distance from the crosswalk. Issues for the school district-parkoing lot to be redone-possibly 3 to 4 years out still. Issues for the neighborhood access—sidewalks east of Summit View Drive. # F. Concerns

a. Safety concerns

Idle free signs?—Yes-we have one in the horseshoe. Buses, also, come in and turn engines off. Discussion of the cars that line up at south gate –don't turn their engines off. Justin will include an Idle Free reminder in the next parent newsletter.

b. Other concerns

Board Meeting update-had students, high school, parents-talking. State has added new required class-that is full year. Concern that this would cut electives. College and Career could be worthwile—but currently it needs some changing. Discussion that fine arts and academics hould not be

separate-they are all part of education. Vote by the school board that night was to continue to let each school decide about schedule.

Lunch discussion-parent concern about appropriate lunch room talking and noise level— students should be allowed to talk at lunch. Are students being quieted too much or harshly? They have 20 minutes to eat and 20 minutes outside—but they do get really loud. Lunch aide is also in their to help monitor the tables. Justin will check on this.
